You Can Create Your Legacy Today

A bequest is the easiest, most tangible way to create a lasting legacy. A bequest is a gift made through your will or trust. There are several ways to make a bequest:

- A specific dollar amount
- A percentage of your estate
- A specific asset
- The residue of your estate

Other ways include:

- Make your favorite charity a beneficiary of your life insurance, pension plan or IRA
- Establish a charitable gift annuity and create a steady stream of income for yourself and/or others
